

THE ZPOINT PROCESS

Requirements to become a Certified ZPoint Practitioner

1. Submit a Certification fee of \$195.00USD and write a test (see below) on The ZPoint Process. The test will be based primarily, although not exclusively, on your knowledge of “The ZPoint Process for Instant Emotional Healing” available as an instant download at <http://www.zpointprocess.com>. The test may be submitted by email in Word format to grant@zpointprocess.com for marking. A passing grade is 80%. Marks will be returned by email within 7 days of submission. *(If a passing grade is not achieved an additional fee of \$25.00 USD will be required for each re-submission)*
2. Once you have achieved a passing grade on the above test, you must submit 5 case histories where ZPoint is the primary modality used. Case histories must involve work with at least three different individuals, and include at least one follow up on each client/patient. Each case history should list the presenting problem and an outline of the steps you took to resolve it. Although the case history does not need to be a record of the session verbatim, it is expected that many of the specific statements used – and some of the client’s feedback given during and after the process – will be included. The client’s identity should be kept entirely confidential. If you do include identifying information, it is your responsibility to obtain the client’s written consent to release that information.
3. Arrange a mutually agreeable time to hold a personal telephone interview with Grant Connolly, Creator of the Process. The purpose of the interview is to discuss your case histories.

OR

1. Attend a day long Certification Training Session led personally by Grant Connolly. The cost of these day long trainings will vary according to location and numbers attending. Such trainings will be arranged as often as possible beginning in the spring of 2007 and details will be posted on the SharingZeroPoint list and through the ZPoint Newsletter.
2. Submit a Certification fee of \$195.00USD along with 5 case histories where ZPoint is the primary modality used. Case histories must involve work with at least three different individuals, and include at least one follow up on each client/patient. Each case history should list the presenting problem and an outline of the steps you took to resolve it. Although the case history does not need to be a record of the session verbatim, it is expected that many of the specific statements used – and some of the client’s feedback given during and after the process – will be included. The client’s identity should be kept entirely confidential. If you do include identifying information, it is your responsibility to obtain the client’s written consent to release that information.
3. Arrange a mutually agreeable time to hold a personal telephone interview with Grant Connolly, Creator of the Process. The purpose of the interview is to discuss your case histories.

It is also recommended, although not a requirement, that you purchase and listen to the Opening to Abundance virtualCD available at www.zpointprocess.com/finCD.html as this will show you how to lead clients through the process. There is no substitute for direct experience with the Process itself.

The Test

Below you will find a list of questions to be answered and submitted as part of the requirements to be Certified as a ZPoint Practitioner. Many but not all of the answers to these questions may be found by thoroughly reading the eBook “The ZPoint Process for instant Emotional Healing, which may be purchased at www.zpointprocess.com/zbook.html.

1. Please discuss in detail and give examples of the concept of “Allowing” as it relates to The ZPoint Process.
2. Please discuss The Law of Attraction as set out in the Teachings of Abraham and give examples and explain why and how it relates to The ZPoint Process. (See recommended information listed above)
3. Please list the different kinds of ZPoint Statements. Describe when and why you would use each and give examples.
4. Please describe the Erase the Tape Method in detail, giving examples of when and how you would use it.
5. Please discuss Patterns (the Pain-Body) as it relates to The ZPoint Process. (for a full explanation please reference Power vs Force and The Power of now as set out above)
6. Please create and list 10 regular ZPoint Statements dealing with any one specific issue of your choosing. (eg. A recent divorce, relationship issue, shyness, body issue, self-esteem etc.)
7. Please describe the Opening Technique. Give 5 examples of Opening Statements as they relate to the issue you outlined in question 6.
8. Please list the statements and methods that you would use to help someone who approaches you with an issue of your choice other than that listed in question 6.
9. Please describe the Fill in the Blanks Technique giving at least 5 examples. Explain why you would use this technique and how it works.
10. Please outline why you wish to become a Certified ZPoint Practitioner and how you plan on attracting clients.

Once you have completed the above test to your satisfaction, kindly attach the Word file to an email addressed to grant@zpointprocess.com.

At the same time, please go <http://www.zpointprocess.com/cert.html> and click on the PayPal “Buy Now” button at the bottom of that page to submit your Certification fee. Tests submitted without the accompanying fee will be returned unmarked.

Once we receive your completed test and Certification fee, we will mark it and advise you of your mark within 7 days. If you pass, you will be invited to submit your case histories and arrange the personal telephone interview with Grant Connolly. The cost of that call will be included in your \$195.00USD Certification fee.

Upon successful completion of the above process, you will receive a Certificate suitable for framing, attesting to your accomplishment and be listed as a Certified ZPoint Practitioner on the ZPoint website.
